Breeding Contract for Cooled Semen

*I, _____ hereby confirm my reservation to the Welsh Pony stallion, *Telynau Falcon for the 20__ season to breed to the mare named _____.

* Fees for the 20__ Breeding Season

2. Refundable Container Deposit \$300.00 (Shipping Charges and additional collections will be deducted from this deposit)

These fees must be sent with your signed contract prior to shipment of semen. (Checks payable to Whitehedge Farm)

The breeding fee includes the first collection. Subsequent collections will incur a \$100 collection fee. Semen is sent by overnight Priority delivery via Fed Ex or UPS. Shipping charges are billed at cost.

*Shipping Containers must be returned within two days of receiving them. Containers should be insured for \$300. Please initial _____

*The stallion owner assumes responsibility to deliver live semen in viable condition at the time of delivery to the approved shipping address. The semen must be administered by a licensed veterinarian. The semen must be administered on the day of delivery. Please initial _____

*I understand that my mare must be (ultrasound) examined by a Veterinarian 15-20 days after the last day bred and Whitehedge Farm notified of pregnancy status at that time. I further understand that my mare must be ultrasound between 35-50 days after the last day bred and Whitehedge Farm notified of her pregnancy status at that time or all live foal guarantees are null and void. Please initial _____

*This contract guarantees return privileges for the same mare to Telynau Falcon during the course of Whitehedge Farm's breeding season. The mare owner is guaranteed return privileges for 2 seasons following the initial breeding season if the above mare is examined by a licensed veterinarian and found to be barren at 55 days from the last date of service. Booking fees, container deposits and collection fees would still be owed by the mare owner. Please initial _____

*Should the mare not produce a live foal that stands and nurses, the mare owner shall be entitled to above mentioned return privileges. A statement of details by a licensed veterinarian must follow within 10 days or this guarantee becomes null and void. If the above mare should fail to conceive or carry a foal to term, another mare may be substituted with prior approval of Whitehedge Farm. Please initial _____

*I understand that the mare owner shall assume all responsibility for the condition of the mare and shall bear all risk or damage to the mare whether by death, injury, infection or otherwise, and therefore agrees to hold the stallion owner harmless for any and all damages. Please initial _____

*I understand that should the stallion die, be sold or become unfit for service prior to shipment of semen to this mare, or if the mare should die or become unfit to be bred prior to being serviced this contract shall be null and void. In the event that the stallion should die or become unfit for service, excellent quality frozen semen will be substituted. Please initial _____

*I have read and acknowledge the information included with this contract entitled "Successful Breeding Guidelines". Please initial _____

*This contract is executed in duplicate and shall be legally binding upon both parties.
